Colleagues,

Election day was a busy day for HCEA; we had dozens of volunteers distributing Apple Ballots to support educatorendorsed candidates. We saw significant victories with our upballot candidates and have varying success in other areas. I heard from many of you about the Board of Education.

While the preliminary results are not what we wanted, we cannot lose sight of the thousands of mail-in ballots left to be counted. The final results may not be complete until next Friday. We will be patient and see what happens. A few more educatorendorsed candidates have a viable chance of winning.

The initial response to the election from many of our members has been fear; I have received dozens of emails and numerous other messages asking how we move forward. The answer is simple. 
HCEA and MSEA held an ESP Listening Session to help create the ESP Bill of Rights. Over 20 HCEA ESP members came to share their story.



MSEA Representative Assembly and Convention

The MSEA Representative Assembly and Convention was held October 21–22 in Ocean City. HCEA sent 43 delegates to the RA, the most HCEA has ever sent. We had more delegates than some of the locals that are far larger than us. This is a testament to the growth and strength of HCEA over the past several years.

It was a productive weekend, full of New Business Items (NBIs), candidate speeches, conversations with Maryland State Superintendent Mohammed Choudhury, and of course, raising money for MSEA's Political Action Committee. One of the most important issues presented was the introduction of the ESP Bill of Rights. Our ESP Vice-President Cindy Poper worked with a statewide committee to hold 13 ESP listening sessions across the state. These listening sessions provided the backbone to the Bill of Rights. Stay tuned for future actions related to the ESP Bill of Rights.

Our very own Jacob Bennett attended his first in-person convention and presented a NBI about the science of reading. It passed with flying colors and requires MSEA to give resources and information about the science of reading on their website. And the MSEA By-law Amendment to reorganize the MSEA Board of Directors to include regional directors also passed, thanks to the work of our President Chrystie Crawford-Smick and many other state leaders working to find a solution so all voices are represented and heard at the BOD table.

Next year's convention will be held October 19–21. If you are interested in attending as a delegate, don't forget to recommend yourself for a position in this year's election. Delegates are chosen by our membership in January election. Nominations for elections are open until November 17th at 3:30 pm. <u>Nominate yourself here</u>!

It was a busy election day on Tuesday. We had 48 HCEA members hand out Apple Ballots of our endorsed candidates to voters. We've never had more educators participating in Election Day and supporting our endorsed candidates. And our numbers have certainly made a difference. Our goal was to help our endorsed candidates get just a few more percentage points on election day, and our efforts are showing: many of the Board of Ed races are too close to call based on the number of mail-in ballots that are still not counted. We will anxiously await the final results of mail-in ballots on November 18th. In the meantime, we will celebrate the good work of our members fighting for their students and their schools.

Know Your Contract: Faculty Advisory Councils (FACs)

All schools are entitled to have a Faculty Advisory Council (FAC) to help solve building level issues. The purpose of the FAC is to provide meaningful teacher input into the operation of our school system at the grass roots level. The FAC should be viewed by the administrators and teachers alike as a creative opportunity to foster teacher involvement and to solve problems in a constructive fashion. Article XXIII in the Certificated contract addresses the FAC, and while the FAC provisions are not in the ESP contract, the FAC includes all members of the HCEA bargaining unit, which is intended to include Education Support Professionals.

ARTICLE 23.1

A FAC composed of teachers shall be established in each school.

ARTICLE 23.2

The committee will consist of not less than three (3) members or more than fifteen (15) members.

ARTICLE 23.2

Members of the committee shall be elected in each school by the teachers during the month of September and shall serve through June 30. In case an elected member cannot serve, a special election shall be conducted to choose a successor.

ARTICLE 23.4

The purpose of the FAC will be to advise the principal with reference to procedures for the operation of the school. The principal shall meet with the Faculty Advisory Committee at mutually agreeable times upon the call of either the Faculty Advisory Committee or the principal, but not later than ten (10) school days from the date of request. The principal shall respond to the committee within ten (10) school days after a meeting between the parties. The principal shall consider the advice of the committee and may submit topics to the FAC for their study and advice.

If you have questions or feel you need assistance getting started, contact your UniServ Director (Liz or Will- please see the UD assignments).

DO NOT USE THE FAC TO ADDRESS A CONTRACTUAL GRIEVANCE!

If the contract is not being upheld (for example, teachers are not getting a planning period), you should IMMEDIATELY contact your UniServ Director (Liz or Will). The grievance procedure must be used to resolve any misunderstandings concerning the Negotiated Agreement.


