# Contract Spotlight

## **PLANS FOR PROFESSIONAL GROWTH WHAT YOU SHOULD KNOW**

As we move into January, we want to clarify an important part of the evaluation process that is often misunderstood: the Plan for Professional Growth (PPG).

A PPG is not disciplinary. The purpose of a PPG, as stated in our contract, is to support an educator's professional growth and development. PPGs may be used for both tenured and non-tenured educators and are meant to provide guidance and support, not punishment.

PPGs are intended to be collaborative. Teachers and administrators are expected to work together to identify goals, supports, resources, timelines, and measures of success. A PPG should not be created or implemented unilaterally. This is a shared process designed to help educators grow, not something that should be imposed without discussion.

It is also important to know that signing a PPG does not mean you agree with it. A signature only acknowledges receipt and participation in the process. If you disagree with any part of the PPG, you have the right to submit a written response to be attached to the document at the time you sign.

If you are placed on a PPG or told you may be, and the process does not feel supportive or collaborative, reach out to HCEA. We are here to ensure the contract is followed and that PPGs are used as intended.

## CONNECTING WITH YOUR BUILDING REPRESENTATIVE

Building representatives serve as a key support for members by helping them navigate questions and concerns, providing guidance and support, and connecting them with HCEA resources when needed.

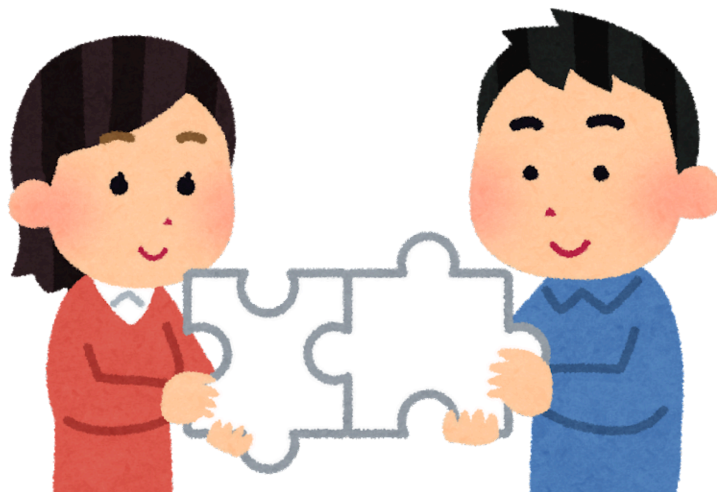
Your building rep is available to you for any reason. You do not need to have a formal complaint or a contract issue to reach out. Whether you have a question, need clarification, want to talk through a situation, or are unsure who to contact, your building rep can help.

Building reps also play an important role in sharing information and supporting members at the building level. They help explain contract related processes, share updates, and raise concerns so issues can be addressed early and appropriately. This connection allows HCEA to identify common issues, address concerns early, and better advocate for members across the county.

January is often a time when questions arise about evaluations, observations, workload, and expectations for the remainder of the school year. Reaching out early can provide clarity and support before concerns escalate.

When an issue requires additional assistance, building reps work with HCEA staff to ensure members receive appropriate support and guidance.

The Education Support Professional (ESP) contract will be fully open, meaning all contract language is subject to negotiation. The certificated contract will have a limited opener, with negotiations focused on two language items and salary.

These negotiations are led by union members who volunteer their time, experience, and knowledge to represent all of us at the table.

# Education in Session

## Maryland's 2026 Legislative Session Begins in Annapolis

The Maryland General Assembly – our state legislature – is set to convene its 449th regular session on Wednesday, January 14, 2026, in Annapolis. The session runs for 90 days and is scheduled to adjourn on April 13, 2026. This yearly gathering of lawmakers is when legislation is introduced, debated, amended, and passed – including bills that affect public education, school funding, teacher working conditions, and other issues important to educators and students.

### How Long is the Session?

Under the Maryland Constitution, the General Assembly meets each year beginning the second Wednesday in January and usually continues for a maximum of 90 days. While an extension of up to 30 days is possible with a supermajority vote, most sessions end around early-to-mid April.

During these three months, legislators:

- Hear testimony from stakeholders and the public on bills,
- Work in policy committees (including education-related panels),
- Debate bills on the floors of the Senate and House of Delegates, and
- Pass Maryland's state budget for the next fiscal year.

### How You Can Contact Your Legislators

If you want to weigh in on legislation or share your perspective as educators, here are easy ways to reach out:

#### Email or Call

Use the email addresses and phone numbers listed above. Calling during session (10am-4pm on legislative days) can be especially effective.

## Maryland's 2026 Legislative Session Begins in Annapolis, Cont.

### Submit Written or Live Testimony

To speak on a bill during a committee hearing, legislators require testimony submissions through the Maryland General Assembly's electronic platform, MyMGA, usually a couple of days before the scheduled hearing.

### Visit Annapolis

If you're interested in observing a floor session or committee hearing, you can visit the State House galleries or watch livestreams online.

### Tips for Effective Advocacy

- Be clear and concise about your issue and how it affects educators and students.
- Include personal experiences from your schools or classrooms.
- Let legislators know you are their constituent (include your home address).
- Follow up if you don't hear back – persistence matters.

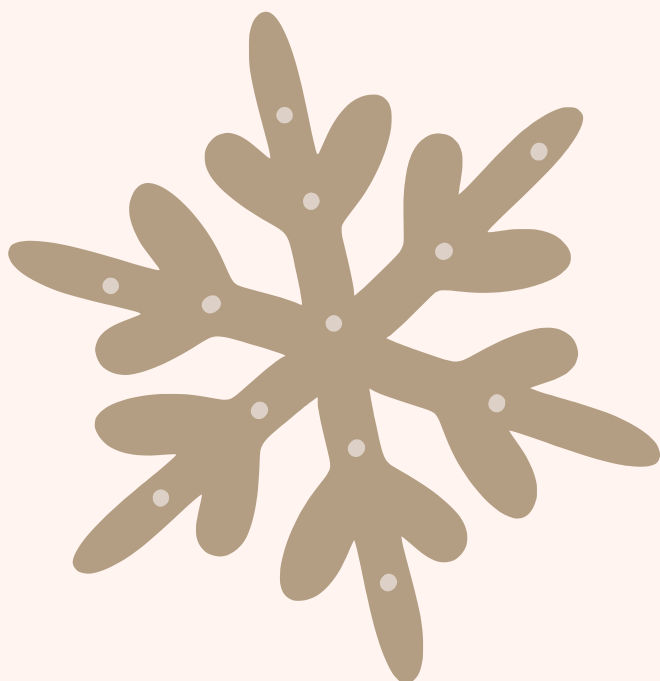



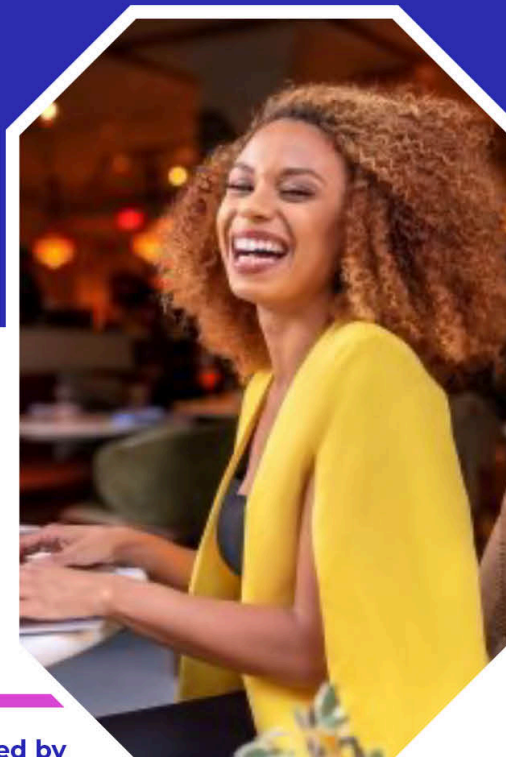

### IMPORTANT INFORMATION ABOUT DISCIPLINE MEETINGS

If you are asked to attend a meeting that may be disciplinary in nature and would like your UniServ Director present, please contact us right away. According to both contracts, you must be given at least 2 business days to get representation.

However, if admin refuses to reschedule, **you must go to the meeting** so you do not face discipline for insubordination.

Just state that you will take notes and write down questions that you will answer after conferring with your rep.
